

General Conditions of Participation by Exhibitors (A)

The Special Conditions of Participation (B) of GES eG and the Technical Guidelines of MOC – Event Center Messe München apply except as these General Conditions of Participation by Exhibitors contain regulations that differ.

A 1 Registration

Those who would like to participate in the trade fair as exhibitors have to declare their wish to do so by registering with GES eG (organizer) as an exhibitor for the trade fair. Registration is done online. The confirmation of registration is sent by e-mail and is to be signed and returned to GES eG. The exhibitor thus declares to GES eG that it is seriously interested in participating in the trade fair as an exhibitor. All co-exhibitors and other companies to be represented at the stand must be identified in the registration form.

A 2 Confirmation of Participation / Admission

By submitting a registration, an exhibitor recognizes as legally binding the Conditions of Participation by Exhibitors A and B as well as the Technical Guidelines of MOC München. An exhibition contract is formed between the exhibitor and GES eG when GES eG notifies the exhibitor in text form that the exhibitor has been admitted to the trade fair. GES eG reserves the right to exclude individual offerors from participating in the trade fair.

A 3 Rental Contract

The rental contract is formed when GES eG has notified the exhibitor in written form that the exhibitor has been admitted to the trade fair. This is normally done upon completion of the layout planning work. The assignments of the other, particularly the neighbouring stands, can still change until the fair begins. GES eG likewise has the right to relocate and close entrances and exits to the fair grounds and exhibition halls and to undertake other structural changes. Claims against GES eG cannot be derived from this.

After the rental contract has been formed, GES eG may still undertake changes in assignments of places and, in particular, change the exhibitor's exhibition area in its location, type, dimensions and size insofar as this is required for reasons of safety, public order, or because the trade fair has been oversubscribed and further exhibitors have to be admitted, or because changes in assignments of places are required for efficient use of the rooms and areas needed for the trade fair. However, the extent of such changes after the rental contract has been formed may not go beyond that which is still reasonable for the exhibitor. If the participation price of the changed area is lower than that of the original area, the difference has to be reimbursed. Further claims against GES eG are barred.

If the exhibitor is not able to use its stand area or is restricted in its use thereof because the stand violates statutory regulations, regulations issued by governmental authorities, provisions of these General Conditions of Participation by Exhibitors (A), provisions of the Special Conditions of Participation by Exhibitors (B) or provisions of the Technical Guidelines of MOC München, the exhibitor is still obliged to pay the participation price in the full amount and to render to GES eG compensation for all damages that have arisen due to the conduct of the exhibitor, its statutory representatives or its assistants, whereby the exhibitor is not entitled to withdraw from or cancel the contract unless it absolutely has such a right by law.

The exhibitor must have the written consent of GES eG before it relocates its stand, trades stands with another exhibitor, shares its stand or turns it over in whole or in part to any third party except as such third parties have already been admitted by GES eG through the exhibitor as co-exhibitors or other companies to be represented at the stand.

A 4 Co-Exhibitors and Other Companies Represented

A co-exhibitor is anyone who appears at the stand of an exhibitor (principal lessee) with its own personnel and its own offer.

If an exhibitor is also a producer, any company whose goods or services are offered by the exhibitor is deemed to be an other company represented by the exhibitor". If an exhibitor is a marketing company that shows not only products of a particular producer but also additional goods and services of other companies, then these companies too are deemed to be other companies represented by the exhibitor. Admission of an exhibitor to the fair does not entail formation of a contract between GES eG and any of the co-exhibitors or other companies represented at the stand that have been registered through the exhibitor. Participation of a company as other company represented by an exhibitor is permissible only if it has been admitted through the exhibitor by GES eG. The exhibitor shall ensure that all its co-exhibitors and other companies represented at its stand observe the Conditions of Participation by Exhibitors A and B, the technical guidelines of MOC München and the instructions of trade fair management.

A 5 Termination of Contract

If the location, type, dimensions and size of the exhibition area rented by an exhibitor are changed to an extent that it is unreasonable to impose on the exhibitor, then the exhibitor has the right to withdraw from the contract provided it does so within a period of one week after receiving written notification from GES eG. Otherwise, apart from the statutory withdrawal rights, the exhibitor no longer has any rights to withdraw from the contract.

If an exhibitor cancels its participation in the trade fair, then, independently of whether the exhibitor has a right to withdraw from the contract, GES eG is entitled to use the rented area in some other way. If an exhibitor cancels its participation in the trade fair even though it does not have a right to withdraw and hence refuses to fulfil the rental contract even though it does not have a reason, then it must pay GES eG the participation price if its exhibition area at the trade fair is vacant or if GES eG has utilized this exhibition area as well as possible in some other way; however, GES eG must grant the exhibitor a credit for the expenses that were spared and for the value of any advantages that were realized through alternate utilization of the exhibition area. Alternative utilization of the exhibition area could, of course, consist of renting it to other exhibitors, but it could also, in particular, consist of allowing a third party which would otherwise have been placed in a different location to use this area so that visitors do not get the impression of a gap between stands, or GES eG

could opt to arrange the rented area so that it does not appear to be vacant. If GES eG has rented the exhibition area to another exhibitor which GES eG would otherwise not have placed in some other location, then the exhibitor shall pay a standard reimbursement of futile expenses in the amount of 25% of the participation price which GES eG incurred because the exhibitor cancelled its participation in the trade fair even though the exhibitor was not entitled to do so. GES eG's rights to demand reimbursement of a greater amount are not affected by this. The exhibitor can demand a reduction of the standard reimbursement of futile expenses if it proves that the expenses incurred by GES eG were less.

The exhibitor does not have a right to changes of the exhibition area that has already been rented, and, particularly, does not have a right to a reduction of this area.

GES eG is entitled to withdraw from the contract if the exhibitor has failed to make a payment that has become due under the contract, GES eG has demanded payment within a 5 day period of grace, and payment was not made by this deadline. GES eG is also entitled to withdraw from this contract if the exhibitor violates its duty resulting from this contract to be considerate of GES eG's rights, objects of legal protection, and interests and GES eG can no longer reasonably be expected to abide by the contract. In addition to withdrawing from the contract in the foregoing cases, GES eG is also entitled to demand of the exhibitor that it pay the agreed participation price as standard compensation for damages. The right of GES eG to demand greater compensation for damages is unaffected by this. The exhibitor can demand that the standard compensation for damages be reduced if it proves that the damages incurred by GES eG were less.

A 6 Force Majeure, Cancellation Rights

If, because of force majeure or other reasons for which it cannot be held responsible (e.g. power outages), GES eG is forced to clear one or more exhibition areas temporarily or for a longer period of time, or to postpone or shorten the trade fair, then no rights of withdrawal from the contract, no cancellation rights, no rights to reduce payments of any kind, and no claims of any kind, particularly no rights to demand compensation for damages, against GES eG shall accrue to the exhibitor because of the said force majeure or other reasons for which GES eG cannot be held responsible. The same shall apply if, because of force majeure or other reasons for which GES eG cannot be held responsible, the exhibitor is not able to participate in the trade fair. If the exhibitor is prevented from participating in the trade fair for a reason that lies in the person of the exhibitor, then clause A 5 of this contract shall apply.

If GES eG cancels the trade fair because force majeure or other circumstances for which GES eG cannot be held responsible have made it impossible or unreasonable for GES eG to conduct the trade fair, then GES eG is not liable for any damages or disadvantages which are sustained by exhibitors because the trade fair was cancelled.

A 7 Participation Prices, Lessor's Security Right, Invoices

The participation prices are computed at the rates stated in the registration. Partial square metres count as full square metres and the floor areas are basically computed rectangularly without consideration of ledges, supports, installation connections, etc.

Payment of the participation price, the communications and waste disposal charges and the fees for admission of co-exhibitors must have been received before the exhibitor can take possession of its exhibition area, be entered in the trade fair media (print, online, possibly mobile) and receive its exhibitor ID cards. Payment deadlines and conditions for all invoices issued by GES eG in connection with the trade fair are regulated by clause B 5 ("Payment Deadlines and Conditions") of the Special Conditions of Participation by Exhibitors (B). In order to secure its payment claims which arise from the rental relationship, GES eG reserves the right to assert its statutory Lessor's Security Right. The exhibitor must, at any time, give GES eG information about the ownership structures of all objects that are or will be exhibited. If an exhibitor fails to meet its payment obligations, GES eG can take possession of objects on display and facilities at the stand ("security") and have them sold in a public auction or on the open market at the exhibitor's expense. Insofar as is permissible under the law, the statutory regulations on realizing this security shall not apply. Liability for damages to such security is not assumed by GES eG except in cases of intent or gross negligence on the part of GES eG.

A 8 Warranty

When it takes possession of its exhibition area, the exhibitor must report any defects in its stand or exhibition area to GES eG in writing without delay, on the last day of assembly at the very latest, so that GES eG can remedy any defects in time. (Contact person on site: Trade fair organisation). Complaints submitted at a later time cannot be considered and cannot lead to any claims against GES eG.

A 9 Liability and Insurance

GES eG is liable for all bodily damage (damage from loss of life, bodily injury, or to health) which results from a violation of duty for which GES eG, its statutory representatives or assistants can be held responsible, as well as for damages which are caused by intentional or grossly negligent violation of duty by GES eG, its statutory representatives or its assistants. GES eG is also liable for damages caused by negligent violation of basic contractual duties by GES eG, its statutory representatives or its assistants, whereby basic contractual duties are those which must be fulfilled if the contract is to be carried out properly at all and on the fulfilment of which the other parties to the contract may regularly confidently depend. In a case of damages resulting from violation of basic contractual duties, GES eG is liable for these damages only if they are typical of the type of contract in question and not indirect, consequential damages, and then only up to an amount of at most 100,000.00 EUR or 5 times the total net participation price per incident, whichever is less.

General Conditions of Participation by Exhibitors (A)

The Special Conditions of Participation (B) of GES eG and the Technical Guidelines of MOC – Event Center Messe München apply except as these General Conditions of Participation by Exhibitors contain regulations that differ.

In no case is GES eG liable to exhibitors for damages to or losses of facilities of the stand or any goods brought in by the exhibitor. Then it makes no difference whether these damages or losses occurred before, during or after the trade fair. The same applies to road vehicles parked on the trade fair grounds by exhibitors or their employees or others working for them.

The exhibitor is liable for any damages to persons or things that are caused by him, his employees, other persons working for him, or by any of his things or facilities at the trade fair, insofar as any of these persons is at fault. Each exhibitor is obliged to take out sufficient insurance against such risks from an insurer licensed to operate in the European Union, and to pay the premiums, including insurance tax, in time.

A 10 Filming and Photographing

Filming, photographing, as well as making drawings and video recordings in the exhibition halls and the exhibition areas on the open air grounds is allowed only when the persons doing so have GES eG's permission for this and are each in possession of an ID card that has been issued by GES eG. In addition, GES eG can allow the exhibitor to carry out professional photographing and filming of the exhibitor's own stand or to have this done by a photographer. The permission for this covers access to the trade fair grounds for the photography or film team outside the trade fair opening hours. If photographs or films are to be made during trade fair hours, valid exhibitor tickets will also be required in order to access the trade fair grounds.

Making photographic or other recordings of stands of other exhibitors is strictly prohibited in all cases. In the event of an infringement, GES eG can apply legal means to demand that the offending photographic or other recordings be surrendered.

The GES eG points out that film and photo recordings will be made during the event. By booking the event, the participants give their consent that they may be identified as a person and that the image material may be used for an unlimited period in connection with the PRO FachHANDEL series of events and their publications.

A 11 Advertising

Exhibitors may conduct promotional measures on the trade fair grounds only at their own stand unless they have applied to GES eG for permission to advertise elsewhere on the trade fair grounds in exchange for a payment, and GES eG has granted this permission. The amount of this payment follows from the order documents for advertising space. GES eG is entitled to stop all advertising on the trade fair grounds that it has not authorized; in particular, GES eG may order persons who have been deployed as advertisers without GES eG's permission to leave the trade fair grounds and GES eG may confiscate, remove and destroy unauthorized promotional materials. If an exhibitor advertises or has advertising conducted by third parties on the trade fair grounds outside its own stand without obtaining GES eG's permission, GES eG is entitled to charge standard compensation for damages in the

amount of twice what GES eG would have demanded for granting permission to conduct the unauthorized advertising. GES eG's right to demand greater damages is unaffected by this. The exhibitor can demand that this compensation for damages be reduced if it proves that the damages sustained by GES eG were less.

A 12 Provision of Food and Drink

As far as GES eG is concerned, the exhibitors are at liberty to provide food and drink at their stands. The statutory provisions, particularly those regarding protection of non-smokers, must be observed. Exhibitors have the option of hiring one of the catering firms under contract with "MOC München for the trade fair grounds to look after their stand too. Deliveries to exhibition stands, especially those from outside the trade fair grounds, are possible only with restrictions. GES eG is entitled to require that deliveries to stands shall be made only at certain times.

A 13 Suppression of Brand and Product Piracy

Each exhibitor is obliged to respect the privileged intellectual property and trademark rights of third parties. The exhibitor agrees now that for the event that the exhibitor is properly advised that it is violating such rights of third parties by exhibiting or offering certain products or services, by presenting them in a certain way, or in some other way, then the exhibitor will remove the offending objects from the stand.

If an exhibitor is prohibited from exhibiting or offering certain products or services or from presenting them in a certain way by means of a decision of a German court, but the exhibitor refuses to conform to this court decision and refrain from exhibiting or offering certain products or services or presenting them in a certain way at the trade fair stand, then GES eG is entitled to bar the exhibitor from the ongoing trade fair and/or future trade fairs until such time as the court decision is annulled by some later decision that is handed down in the course of appeals proceedings. In such a case, the participation price will not be reimbursed (neither in whole nor in part). GES eG not obliged to review the court decision for correctness. There is no legal right to exclusion of the exhibitor to whom the court decision applies. If the court decision on which such exclusion was based is annulled by some later decision that is handed down in the course of appeals proceedings, then the exhibitor which was lawfully excluded on the basis of the earlier court decision shall have no rights to compensation for damages by GES eG.

If an intellectual property panel is active with the agreement of GES, its members are entitled to enter the exhibitor's stand at any time and examine the exhibits there for violations of intellectual property rights, or originator's rights or competition rights of the persons who appealed to the said intellectual property panel.

A 14 Exhibitor ID Cards

The exhibitors receive free of charge the number of exhibitor ID cards defined in the Special Conditions of Participation by Exhibitors (B) for the entire time of the trade fair. Additional exhibitor ID cards are available in exchange for payment. The exhibitor ID cards are num-

bered and cannot be transferred. Exhibitor ID cards may not be passed on to unauthorized third parties such as persons or companies which want to peddle their goods or render their services on the trade fair grounds without having been admitted by GES eG. Exhibitor ID cards are not issued to an exhibitor until payment of the participation price, advance payment of services and the fees for admitting any co-exhibitors have been received.

A 15 Assembly and Disassembly of Stand, Personnel at Stand

The assembly and disassembly times and deadlines stated in the Special Conditions of Participation must be adhered to exactly. If an exhibitor has not taken possession of its stand by the last day of assembly, then GES eG can use it some other way.

Each exhibitor which has been admitted is obliged to participate in the trade fair. All stands must be properly equipped and staffed with competent personnel during the opening hours prescribed for the entire trade fair. In particular, each stand must already be fully staffed when the trade fair opens. One may also not remove trade fair goods or disassemble stands before the trade fair is over; violation of this rule will entitle GES eG to demand payment of a contract penalty of 300.00 EUR. GES eG's right to demand greater compensation for damages is not affected by this. The exhibitor can demand reduction of this standard compensation for damages if it proves that the damages sustained by GES eG were less. If an exhibitor fails to keep its stands staffed with appropriate, qualified personnel during the trade fair opening hours, or displays an incomplete offer or one which has not been admitted, or leaves its stands early or clears them or otherwise violates the conditions of participation, GES eG is entitled to exclude the exhibitor from future trade fairs without prejudice to GES eG's rights to cancel the contract for cause pursuant to "A 5 Termination of Contract" and assert all damages sustained by GES eG for this reason.

A 16 Oral Agreements

All oral agreements, individual approvals and special arrangements apply only after confirmed in writing by GES eG.

A 17 House and Usage Rules

The house and usage rules for the trade fair grounds must be followed by exhibitors to the letter. Sleeping overnight in the halls or on the open air grounds is prohibited. Exhibitors are obliged to be considerate of the other participants at the trade fair, not to do anything that is unethical or contrary to accepted moral standards, and not to misuse participation in the trade fair for any purposes, such as religious or political purposes, which are foreign to the purposes of trade fairs.

The employees of GES eG have the right to enter the exhibitor's stand on behalf of GES eG.

A 18 Statute of Limitations, Exclusion Period

All claims of the exhibitor against GES eG that arise from renting a stand or from any of the legal relationships related to rental of a stand lapse within 6 months. This limitations period begins with the end of the month in which the last day of the trade fair falls. Without prejudice to the regulations of clause A 8, complaints related to an invoice must be asserted in writing within 14 days after the invoice was delivered.

A 19 Place of Fulfilment, Applicable Law

If the exhibitor is a merchant a legal entity of public law or a special fund under public law, then Nürnberg is agreed as the place of fulfilment, also for all payment obligations. German law, and only German law applies.

A 20 Place of Jurisdiction

Nürnberg is agreed as the place of jurisdiction for all disputes that arise from or in connection with this contract if the exhibitor is a merchant, a legal entity of public law or a special fund under public law or if the exhibitor does not have a general place of jurisdiction in the Federal Republic of Germany. GES eG may also opt to assert its claims against the exhibitor at the court which has jurisdiction for the place at which the exhibitor has its seat of business or a branch office.

A 21 Data Protection

The exhibitor's person related data is processed and used in accordance with the statutory data protection regulations in order to fulfil the business purposes of GES eG and MOC München, and, in particular, is also passed on to third parties in the context of fulfilling the purpose of the contract.

A 22 Severability Clause

In the event that the Conditions of Participation or the Technical Guidelines of MOC München are legally ineffective in part, or fail to regulate subject matter which must be regulated ("gaps"), then this shall not affect the validity of the remaining provisions or of the contract considered as a whole. In such a case, the parties agree that they will replace ineffective provisions and fill gaps with regulations with which the economic purpose pursued by the parties can best be achieved.

A 23 Value Added Tax

The charges and fees stated in the General Conditions of Participation, the Special Conditions of Participation and the Technical Guidelines of MOC München are net charges and fees. They will be charged together with the applicable German value added tax insofar as they are subject to German value added tax under the turnover tax law that applies in the Federal Republic of Germany.

B 1 Registration

B 2 Admission of Exhibitors

All German producers, all producers from another country or its branches in Germany, general importers, specialist dealers authorized by producers or services company as well as any firm authorized by a producer's factory to exhibit its products can be admitted to the trade fair as an exhibitor. GES eG decides on admission and the exhibition area that is requested. Organizers of joint stands are not exhibitors within the meaning of these "Special Conditions of Participation (B)".

B 3 Stand Fees, Advance Payment for Services (see A7)

The stand fees are computed at the rates stated in the registration.

The stand fee covers both the rent of the stand area and comprehensive services provided by GES eG, including advice on layout planning for the stand, advice regarding the local technical circumstances and requirements to be kept in mind when designing one's stand, advice on assembling and disassembling the stand, the conceptional and public relations work for the trade fair, visitor marketing and advertising for the trade fair, preparation and conduct of trade fair related press conferences, presentations and exhibitor evening events (insofar as organized by GES eG), preparation and conduct of forums and special exhibits (insofar as organized by GES eG or by third parties on behalf of GES eG), provision of exhibitor ID cards for entry to the trade fair as in clause B 12 "Exhibitor ID cards", provision of entry vouchers for visitors in accordance with clause B 13 "Voucher 2-day-ticket", provision of promotional materials, lighting, heating and air conditioning of the indoor exhibition areas, basic surveillance of the trade fair grounds, regular cleaning of the public areas, provision of loud speaker systems for announcements to the visitors, and other visitor information systems including signs, provision of gastronomic facilities for exhibitors, visitors and representatives of the press in the exhibition indoor areas, the presence of paramedics and direction of road traffic to the trade fair grounds and within the trade fair grounds.

Each exhibitor is charged a **mandatory communications and waste disposal contribution** in the amount of **95.00 EUR**. This required communications contribution covers the extended basic entry in the fair catalogue (print, online, see B 11 Media Services)

The **waste disposal contribution** covers all waste that accumulates at the exhibitor's stand during assembly, disassembly and the entire trade fair time. (Stand construction materials excluded!).

Waste must be disposed of in accordance with the regulations in the Technical Guidelines of MOC - Event Center Messe München.

Voucher 2-day-ticket

The communications contribution also covers a limited number of vouchers for a 2-day-ticket (see B 13).

Special Conditions of Participation (B)

The General Conditions of Participation (A) of GES eG and the Technical Guidelines of MOC - Event Center Messe München apply except as these Special Conditions of Participation contain regulations that differ.

B 4 Co-Exhibitors (logo partners)

Other companies can, in principle, participate as co-exhibitors (see A 4). This requires that such a company be admitted by GES eG in advance. There is no charge for participating as a co-exhibitor. But the company can be admitted only if it also could have been admitted as an exhibitor (see nomenclature, B 17). A mandatory communications and waste disposal contribution in the amount of **45.00 EUR** is charged for each co-exhibitor. This mandatory communications and waste disposal contribution covers the same services for the co-exhibitor as it does for the main exhibitor (see B 3).

Co-exhibitors must be registered on the registration form for main exhibitors.

GES eG is entitled to demand that the exhibitor pay GES eG a contract penalty of **500.00 EUR** for each co-exhibitor which has not been admitted by GES eG. In addition, GES eG can demand of the exhibitor that co-exhibitors which have not been admitted by GES eG clear the stand. If the exhibitor does not comply with this demand without undue delay, then GES eG has the right to cancel the contractual relationship between GES eG and the exhibitor with immediate effect.

B 5 Payment Periods and Conditions (see A7)

The invoice amount of each invoice issued by GES eG in the context of the trade fair is to be paid in euros into one of the bank accounts stated in the invoice without any deductions or bank charges, whereby the payment order should state the customer number. The payment deadline stated in the invoice is binding and must be met.

B 6 Parking Spaces

Parking on the trade fair grounds is prohibited. Motor vehicles that are parked unlawfully will be towed away at the holder's expense.

Information about parking spaces for passenger vehicles and lorries and about the opening hours of the car park can be obtained through the organizer or the MOC - Event Center Messe München team.

The price per parking space per day (24 hours) is between 16,00 and **30.00 EUR** inclusive of VAT.

More informations look at form „PARKEN 2026“ from MOC - Event Center Messe München.

Insofar as open air parking spaces are available for passenger vehicles and lorries: Passenger vehicles over 2 m high and lorries can use the parking areas adjacent to the trade fair grounds against payment of a fee. Long-term parking tickets can be bought at the entrance gate (payment in cash only).

Trade fair construction companies and suppliers will not be let in before 16:00 hours on 17 September 2026.

The assembly and disassembly times and deadlines stated in the Special Conditions of Participation must be adhered to exactly. If an exhibitor has not taken possession of its stand by the last day of assembly, then GES eG can use it some other way. Each exhibitor which has been admitted is obliged to participate in the trade fair. All stands must be properly equipped and staffed with competent personnel during the opening hours prescribed for the entire trade fair.

Trade fair goods may not be taken away and stands may not be disassembled before the trade fair has closed. A penalty fee in the amount of 300.00 EUR will be charged in each case of non-compliance. (see A15)

Special Conditions of Participation (B)

The General Conditions of Participation (A) of GES eG and the Technical Guidelines of MOC - Event Center Messe München apply except as these Special Conditions of Participation contain regulations that differ.

B 8 Stand Construction, Design and Equipment

The exhibitor is responsible for the equipment and design. The exhibitors are obliged to design their stands carefully and appealing.

Stands, the inadequate design of which impair the overall picture of the fair or hall, will not be accepted by the organizer and will be subject to corresponding conditions. The same applies to inadmissible advertising statements.

The overriding principle of the design of all exhibition stands is transparency. All open sides of the stand must be freely accessible.

This means that at least **50%** of the respective aisle side must not be adjusted with superstructures.

The minimum height is 2.50 m.

The stand boundaries, which directly connect to other exhibitors, must not exceed 3.50 m in height for all stand types.

The back of the booth boundaries, advertising media or other design elements for the neighboring booth over 2.50 m high must be designed and cleaned neutrally. They may not contain any text or graphics.

Exhibition stands from 400 m² are generally subject to approval. This also applies to exhibition stands that exceed the height of 3.50 m.

Attention:

Hall 4: The maximum height is 4.00 m!

The floors of the stands must be covered by the exhibitors with a suitable covering (e.g. carpet, parquet, PVC).

For the entire duration of the event, the name and address of the stand owner must be displayed on the stand in a manner that is recognizable to everyone.

The exhibitor undertakes to install a 2.50 m high stand wall on all closed sides of the stand area.

If no stand limitation or no rental stand is used, stand partitions must be ordered from the service partners. Foil-coated or non-wallpapered stand partition walls can be rented.

If no rental exhibition stand is used, the attachment of a front panel (0.30 m high) is made a requirement on all open sides of the stand area.

The front panel can be omitted if the required stand quality is guaranteed in another way. Stand partition walls, floors, hall walls, pillars, installation and fire protection equipment as well as other fixed hall installations must not be stuck on, nailed, painted or otherwise damaged.

Damage will be borne by the exhibitor and will be invoiced. Any pillars located in the stand area as well as installation and fire protection devices are part of the allocated stand area and must be accessible at all times.

Floor coverings in the exhibition stands may only be attached with double-sided adhesive tape (only with solvent-free adhesive tapes: tesafix No. 4964).

If residues on the hall floor have to be removed by other adhesive tapes after dismantling, the cleaning costs will be charged to the exhibitor. The same applies to remnants of carpets or similar.

The exhibitor undertakes to comply with these requirements. Failure to do so may result in claims for compensation by the organizer or the neighboring exhibitor concerned.

B 9 Deliveries

The exhibitor must ensure that at the time when a delivery are made, personnel who can accept the delivery are present at the stand MOC München personnel are not allowed to accept deliveries and will therefore, should the exhibitor not be available to accept the delivery, direct the supplier to the trade fair freight forwarders – the costs for intermediate storage and delivery later on will have to be borne by the exhibitor. All deliveries outside the official assembly and disassembly hours have to be made to one of the trade fair's freight forwarders. No liability can be assumed for any objects left behind after that time. Any costs that arise for removal, intermediate storage or waste disposal of such objects shall be borne by the exhibitor.

B 10 Technical Facilities

The technical services mentioned as such in the Technical Guidelines of MOC - Event Center Messe München, such as installations of power and water supplies at the stand, can only be ordered through GES eG.

WLAN (Wireless Local Area Network)

Exhibitors are only permitted to set up a WLAN (Wireless Local Area Network) with the express written approval of the ° MOC - Event Center Messe München trade fair service.

B 11 Media Services (Catalogue – Internet)

The basic entry is invoiced by GES eG (see B 3) and contains the following services: in the trade fair catalogue:

- Inclusion of the company name, street, post code, place, Hall / stand in the alphabetic exhibitor directory
- Inclusion of the company name, Hall / stand number under 1 product group in the exhibitors' directory by products
- Trade fair offer

The exhibitor bears sole responsibility for the legal admissibility of the entries included in GES eG's trade fair catalogue (print or online) at the exhibitor's initiative, especially the legal admissibility of these entries from the point of view of competition law. If third parties assert claims against GES eG because of legally inadmissibility of the exhibitor's entries, including inadmissibility under competition law, then the advertiser shall indemnify GES eG comprehensively against all asserted claims including all costs of necessary legal defence on the part of GES eG.

The same applies to entries of exhibitors, co-exhibitors, and exhibitors at joint stands whose entries were placed by the exhibitor in GES eG's trade fair catalogue (print or online).

B 12 Exhibitor ID Cards

Each exhibitor receives free of charge the number of exhibitor ID cards stated below for the entire time of the trade fair.

In the Hall

Stand size 11 - 20 m²:	4 exhibitor IDs

Additional exhibitor ID cards can be ordered at the price of 59.00 EUR per ticket. The exhibitor ID cards are intended only for the persons who look after the stand and may not be passed on to third

parties. In a case of misuse, GES eG is entitled to retract the exhibitor ID card. Admission of co-exhibitors does not increase the number of exhibitor ID cards.

The exhibitor ID card will entitle you to participate in our exclusive evening programme, provided you register for it in advance.

The exhibitor ID card does NOT give you the right to use MVG (Münchener Verkehrsgesellschaften) free of charge.

B 13 Vouchers

This promotional offer gives exhibitors, co-exhibitors and companies at joint stands the option to use the digital Voucher. You can distribute this voucher, for example, by email or post. You will find the code of the voucher in your own exhibition portal. All redeemed vouchers for a 2-day-ticket or online vouchers are contained in the participation price and will not be charged.

B 14 Photo, Film and Video Recordings (see also A 10)

Approval by GES eG is required for professional photo and film recordings of the exhibitor's own stand during the entire trade fair except as the exhibitor hires persons who have already been admitted for this and have an ID that has been issued by GES eG.

B 15 Noise, Background Noise

Video and music presentations, shows, etc. during the trade fair hours (see opening hours) must have been approved by GES eG in advance and must be carried out so that the neighbouring exhibitors are not disturbed. Consequently, loudspeakers and other acoustic sound intensifiers/ultrasound systems must be directed to the trade fair stand and must not affect neighbouring stands or corridors. The volume at the boundary of the stand may not exceed 60 dB (A). Even though GES eG's permission has already been obtained, GES eG still has the right to limit or forbid presentations which cause noise or an optical nuisance or which lead to a significant hazard or impact on the trade fair for other reasons. The governmental regulations must also be observed. The boundary value for machines is 70 dB (A).

B 16 Restoration of Exhibition Space to Original Condition

All exhibition areas must be returned to GES eG in their original condition by the fixed disassembly deadline.

If, after the disassembly deadline, necessary restoration work has not been carried out, then GES eG is entitled to have this done by one of its contractors at the expense of the exhibitor.

These participation conditions are subject to changes and supplements by GES eG.
